Re: United Gilsonite Laboratories Asbestos Personal Injury Trust (“UGL Trust”) – Claim Filing Deadline

Dear Claimant or Claimants’ Counsel:

This notice is to remind Claimants and Claimants’ Counsel of the provisions of Section 5.1(a)(2) of the First Amended United Gilsonite Laboratories Asbestos Personal Injury Trust Distribution Procedures (as may be amended from time to time, the “Trust Distribution Procedures”) regarding the upcoming **June 17, 2019** filing deadline applicable to certain claims. ***This is less than one month from today.***

Key dates:

United Gilsonite Laboratories (“UGL”) filed its bankruptcy petition on March 23, 2011. The Initial Claims Filing Date with the Trust was June 17, 2016.

Diagnosis Prior to March 23, 2011 (UGL Petition Date)

Claimants diagnosed prior to March 23, 2011, ***must file a claim with the Trust no later than midnight Central Time on June 17, 2019***, if any of the following conditions are met, provided the applicable statute of limitations did not bar the claim at the time of the event described below:

- a. Filed a claim by lawsuit against UGL or by administrative submission of the claim to UGL prior to March 23, 2011;
- b. Tolloed the claim against UGL prior to March 23, 2011, by agreement or otherwise, provided such tolling was still in effect as of March 23, 2011;
- c. The then-applicable statute of limitations for the claimant’s injury was still running as of March 23, 2011.

Diagnosis On or After March 23, 2011 (UGL Petition Date)

Claimants first diagnosed on or after March 23, 2011 may file a claim with the Trust ***within three (3) years after the date of diagnosis or by midnight Central Time on June 17, 2019, whichever occurs later.***

Please note that nothing in this letter modifies the Trust Agreement or the Trust Distribution Procedures, as amended (“the “Plan Documents”), and in the event of any conflict between this letter and the Plan Documents, the Plan Documents shall prevail.

To ensure timely filing of claims, the Trust encourages use of the electronic filing options described in the filing instructions available at www.UGLTrust.com. **Please take notice that all claim filings must include the \$50 filing fee to be considered filed and toll the statute of limitations.** If you have further questions, please contact the Trust’s claims administrator using any of the following methods:
